ORDINANCE NO. 1993-1

ORDINANCE OF THE BOARD OF DIRECTORS OF THE ARMONA COMMUNITY SERVICES DISTRICT ESTABLISHING MANDATORY SOLID WASTE COLLECTION AND DISPOSAL

WHEREAS, the Board of Directors of Armona Community Services District have duly considered the adoption of an Ordinance establishing a mandatory solid waste collection and disposal; and

WHEREAS, the Board has determined that the adoption of this enabling Ordinance and the future implementation of procedures pursuant thereto appear at this time to be in the best interest of all taxpayers and residents within the Armona Community Services District; and

WHEREAS, the Board of Directors of Armona Community Service District finds that this Ordinance is necessary to protect and promote the public health, safety, convenience, comfort and welfare of the inhabitants of said District.

NOW, THEREFORE, the Board of Directors of Armona Community Services District pursuant to Government Code Section 61600(c) does ordain as follows:

- (1) Solid waste collection and disposal thereof of the Armona Community Services District shall be binding upon all persons within the boundaries of Armona Community Services District.
- (2) All dwellings, apartments houses, and places of business in which solid waste accumulates within the District shall be required to use the solid waste collection service of the District and to pay the charges set forth in future ordinance or resolution to be adopted by the Board of Directors of the District setting rates, pursuant to Government Code §61621.
- (3) All those dwellings, apartment houses, and places of business in which solid waste accumulates outside the District boundaries, but who receive other District services, shall be required to use the solid waste collection services of the District and to pay the charges set forth in future ordinance or resolution to be adopted by the Board of Directors of the District setting rates.
- (4) The effective date of the mandatory solid waste collection and the rates therefor shall be imposed by future ordinance or resolution based upon the winning bid after submission of proposals to various private sector solid waste disposal operators with demonstrated successful experience or capacity in their fields.
