

RESOLUTION NO. 2018-03

A RESOLUTION OF THE BOARD OF DIRECTORS  
OF THE ARMONA COMMUNITY SERVICES DISTRICT  
REGARDING RATES FOR LIFT STATION SERVICE

The Board of Directors of the Armona Community Services District does hereby find:

WHEREAS, the District has previously adopted Ordinance No. 2004-1 providing for charges for operation, maintenance, repair and replacement of sewer Lift Station 1 providing services for homes in Tracts 756 and 787 (collectively Armona North); and

WHEREAS, said charges for Lift Station 1 were based on the best information available at the time of adoption and were allocated equally per house per month; and

WHEREAS, since adoption of Ordinance No. 2004-1 the number of homes served has increased, increasing the rate base, and experience of the costs of operation, maintenance, repair and replacement of Lift Station 1 have increased such that the monthly per home cost of Lift Station 1 may be reduced.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE ARMONA COMMUNITY SERVICES DISTRICT that the Armona Community Services District and its Board of Directors does hereby resolve as follows:

1. That commencing with the District's July 2018 utility billings, that the charge for Lift Station 1 serving the Armona North subdivision portion of the District be reduced to \$5.05 per month per house.
2. That the Board reserves the right to increase the monthly per home charge of Lift Station 1 should circumstances so require, so as to equitably allocate the cost of Lift Station 1 to the homes benefitted by it.

WHEREFORE, this Resolution is passed and adopted by the Board of Directors of the Armona Community Services District on July 10, 2018, by the following vote:
